REPORT TO VESTRY INTERIM PRIEST-IN-CHARGE

I begin with some much-needed acknowledgements. Firstly, to the Wardens, especially Barb Wotton who have guided me to become familiar with the parish and its practices. While my appointment is only temporary, to fill the interim period during the search for a new Incumbent, the Warden's assistance has been of value and is greatly appreciated. I want to thank Cathy Reynolds, the parish administrator, as she too has helped me become familiar with the parish and has provided the "liturgical history" of the various worship services. My thanks to the choir and Carmine Lappano, for both the outstanding choral work and for his willingness to include some of my hymn requests. Finally, but certainly not least, I thank the congregation for your love of this parish and the many kind comments expressed regarding my homilies and humour. Your love of this parish will hold you well as you enter a relationship with a new Incumbent, sometime this year.

The year 2022 was a time of change, and perhaps for some upheaval. Your beloved Incumbent, the Rev'd Canon Judy Herron-Graham retired and laid down her pastoral and spiritual responsibilities for the parish. Together with her husband Andrew they were a muchneeded part of this parish. You held a joyful celebration of thanksgiving upon her retirement, and that initiated the transition to my ministry. Now you are at the final stages of the search for a new Incumbent. Who that individual shall be and when their charge will begin is still in the hands of God and the Bishop. It will be another time of change and relationship building. I am confident you will show the same respect and warmth as you have shown me, to whomever this person shall be. Together you will work toward a new future.

During the past three years society became less social and many primarily only thought about the self. Lockdowns, fears of the unknown, closures and the like all exacerbated this current state of "me only." I fear the same has become true in the life of the Church. Those of us who bravely worked through these past challenging times, financially supporting a shuttered church, now feel as if these new times should be a "reward" for what we endured. But selfishness, a me only attitude, will not bring about a future that God is calling us toward. When the great cathedrals were being built, those who laboured and those who financially supported the effort, many never saw the completed cathedral. Death came in the interval it took to erect the magnificent structure. They built and financed for a future, perhaps a yet unborn congregation that would reap the benefits of the generation before. I believe the same is true today – we all need to put our efforts into the generation(s) that are yet to come.

This current age will require the Church to think differently. Like it or not we are now in a digital age. How will be proclaim the gospel digitally? This new age will be a time of great choice. How shall we present ourselves to be a good choice amongst so many options? This new age will be about challenges, both social and environmental, so how will the Church's message speak to these issues? This is the stuff of a new emerging ministry, which cannot be done by the ordained priest alone – it will require a community effort.

To move toward your future you will need to embrace what you have learned from your past, utilizing the strengths and resiliency discovered during the pandemic and then form new ways in which to be the church. In the Exodus story, early into the wilderness experience some decided they needed to secretly return to Egypt to retrieve the bones of Joseph. The bones represent past strengths, and so I would hope that with the guidance of your new incumbent you retrieve those past strengths and bring them forward. Also, it was the wilderness time where the people worked out a newer way in which to be the people of God. The old Egyptian ways would no longer apply. So, the ancient Israelites formed themselves into tribal units, elected a priestly class, received some laws from God and worked out a new way in which to live. The old familiar ways of being the church are by and largely gone – it is time for a new wine skin to house the new wine God is pouring into this parish. Finally, the Exodus was not accomplished overnight, rather the people moved toward the promised land in stages. There were times when they remained at an oasis and reflected and modified their newer behaviours. Then they would move on. You will discover that the process of moving toward your future will not be a smooth one, but one where you will need time to openly share what is working and what isn't; a time to trust that each one of you has something to offer. And remember – God is with you, just as God went before the people, met Moses at the tent of meeting, and led the way toward their future. Never forget that just as God provided manna in the desert, God will provide you what is needed for this journey ahead of you as you bravely, faithfully, and joyfully move toward your future.

Now, let us remember those who in this past year have entered the full glory of Our Saviour and Redeemer: Jean Crook, Nancy Miller, Betty Raitt, Delphine Thompson, Carlyn Webster, and June Wildman. Rest eternal grant unto them O Lord and let light perpetual shine upon them.

The College of Bishops Pastoral Letter to Vestries, 2023 to be read or circulated on the Sunday of the parish's annual vestry meeting

To the clergy, churchwardens, and parishioners of the Diocese of Toronto:

Dear friends,

Grace to you and peace from God our Father and the Lord Jesus Christ (2 Cor. 1:2)

As we come to our Annual Vestry Meetings, it is a good time for us to reflect with thanksgiving on the past and look with a sense of hopefulness to the year ahead.

The past year was significant in many ways in the life of our Diocese. First, we have been returning to some sense of normalcy after two years of Covid lockdowns and restrictions. While we continue to urge parishes to exercise caution, many of our communities have returned to something that resembles our pre-pandemic life together. We thank God that the worst of the pandemic now seems behind us.

Of course, parishes are continuing to grapple with the effects of Covid. Many of our churches continue to experience a decrease in Sunday attendance, fewer volunteers to fill key parish roles, and a diminished number of regular financial givers. Clergy and lay leaders also continue to experience a deep sense of fatigue and anxiety about the future. In that light, we continue to encourage a gentleness with one another and a renewed commitment to self-care as we navigate post-pandemic realities. Over the past year, we have been pleased to offer a mini-Sabbatical opportunity for clergy. These ten days – taken together or broken up – are intended for rest and renewal. We have been delighted to hear that many clergy have already taken a mini-Sabbatical or have made plans to do so in 2023.

The past year also saw the launch of "Cast the Net", a strategic visioning process for our Diocese. Ably led by the Very Reverend Peter Elliott, Canon Ian Alexander and Dr Anita Gittens, ODT, the Cast the Net team has surveyed the clergy in the Diocese in various consultations, and is now engaging lay people from every parish across the Diocese. Based on John 21, this Biblically-grounded initiative is seeking to help us chart of path forward as a Diocese. We eagerly anticipate a full report from the Cast the Net team at our Synod next November.

Our restructuring of episcopal leadership also continued through 2022. The Episcopal Leadership Implementation Team followed up the good work of the Episcopal Leadership Working Group and brought forward a model for raising up and deploying territorial archdeacons and canon administrators to assist the bishops in their work. Interviews took place in November, leading to the appointment of four new archdeacons and one new canon administrator. Many of you were present at the Cathedral on January 15 as Archdeacon John

Anderson, Archdeacon Theadore Hunt, Archdeacon Steven Mackison and Archdeacon Cheryl Palmer and Canon Laura Walton were collated. They have now begun their work and are already helping to share ministry with the College of Bishops.

After twenty years of service, Canon Clare Burns also retired as our Chancellor and is now Chancellor Emeritus. We are grateful for Clare's ministry and are also delighted to welcome Marg Creal our new Chancellor. Those of you who were present at the New Year's Levee on January 1 will remember the joy of Chancellor Creal's installation.

Our work in the area of anti-bias and anti-racism (ABAR) also continued in 2022. The workshops for clergy concluded last year and we began to roll out the parish-based program. Clergy and lay facilitators are now trained to visit parishes and lead this important work. The ABAR Pod has also been formed to lead the ongoing work of dismantling bias and racism in our structures. May God continue to bless our efforts and encourage us in this vital work.

As we look ahead to a new year, we do so with a sense of great hope. Our beloved Church has changed dramatically over the past few years and will continue to change. But God is present and faithful, and our proclamation and sharing in the redemptive love of God in Christ continues to be the mission to which we are called.

Be assured of our prayers for each of you as you meet for your Annual Vestry Meeting. We want to express our profound thanks to all who exercise leadership in the Diocese of Toronto. Whether you are stepping down from a particular ministry, or continuing on, or taking up a new role this year, thank you for your commitment and faithfulness. You are a blessing to the Church in our Diocese.

We write this letter on the Feast of the Conversion of St. Paul. As the Church celebrates the beginning of Paul's evangelistic ministry to the Gentiles, please join us in praying and working for the extension of the Gospel in every place, and for the renewal of the Church in our midst.

WARDEN'S REPORT TO VESTRY 2023

"Oh give thanks to the LORD; call upon his name; make known his deeds among the peoples!" 1 Chronicles 16:8

Since our last Vestry, much has happened at St. George's. Below is an update since February 2022.

Wardens

In July Margaret Lapierre resigned from her position as People's Warden. We all wished Margaret well and expressed our sincere gratitude for her work as People's Warden. She has agreed to continue her work on the Building and Maintenance Committee. Frank McGilvery agreed to move from his position as Deputy People's Warden to People's Warden. Thank you Frank for your ongoing commitment to St. George's.

Cowan House:

On April 28th 2022 Corporation agreed to the amended offer by the buyer Central Clearview Construction Development to purchase the Cowan House property for a price of 2.5 M with all conditions removed and a closing date of June 15th. Corporation consulted with our lawyer and others with commercial real estate knowledge before making this very difficult decision. The funds from the sale are being held in trust at the Diocese and can be accessed as needed to cover our expenses for the vestry approved roof, elevator and upper hall offices projects. We have not received a final figure regarding how much of the proceeds of the sale will be deposited into the trust account. A rough estimate of the amount deposited is just over \$2 M. We have been working with the Diocese to ensure we are using proper processes for paying and accounting for our bills related to projects.

Sale of Items From Cowan House

Don Clement and his daughter Rose worked diligently to salvage many building items along with other items which were sold on-line. These sales garnered funds of over \$6,000 for the church. Special thanks to Don and Rose for their dedication and hard work.

Judy's retirement

The Wardens were very sad that our beloved Pastor Judy retired at the end of August, with her last day being July 31st. Pastor Judy made a huge impact on this Parish and in our community - we wish her well as she enters her next chapter! Her retirement celebration was a great success with many parishioners gathering to wish her a fond farewell. Thank you to all who assisted with the festivities. Contributions to the event allowed us to rent space at the '420 Wing' as well as decorate and provide food and beverages for the 'Celebration Tea'. A gift basket was presented to Pastor Judy as a token of our love and support. The gift basket included several items including a gift of \$4000 to be enjoyed in her retirement.

Interim Priest

We welcomed the Rev. Richard Newland September 1, 2022. We are very grateful to have Richard as our Priest-In-Charge while we search for Judy's replacement.

Roof Project

The Parish Project Committee that has been established to oversee the Roof project as well as the parish hall elevator and upper hall office projects and will now report as a separate ad-hoc committee. Please see the Project Committee report for updates.

Hall Renter - Venturers

On May 12th, 2022 we discovered that the individual who leads the Scouts Venturer Group that meet at St George's was arrested and charged with several offences involving child pornography. We immediately contacted Bishop Riscylla Shaw who contacted Canon John Anderson as per policy. We were instructed to speak to Scouts Canada to ensure that this person is no longer with the group and that she will not be allowed on the property. We have followed the Sexual Misconduct Policy guidelines as well as notified our insurer, Aon Insurance, who have made a note in their files in case of further action.

Internet and Telephone

We had some challenges with our internet and telephone systems in the spring of 2022. Bell Canada finally decided that we needed new telephone / internet wires and box in order to fix our internet and telephone problems. We are looking into more reliable internet and phone options for us to consider for the future.

Sound System

We have been made aware that the choir and those sitting in the Sanctuary are unable to hear the church services. We did make some adjustments to the system in the fall of 2022 and, although the overall sound has improved, it is still challenging for those in the choir and sanctuary to hear. We are approaching several companies to advise us on the best options for improving the sound in the church. Stay tuned for further updates!

Fire Inspection

Our annual fire inspection was performed by GC Electric on May 2nd,20222. A number of small deficiencies were remedied and the fire suppression system in the Lower Parish Hall kitchen underwent required regular maintenance.

Fire Monitoring

Our Fire Monitoring service was provided by Sage Electric but their service over the past several months has been suboptimal and the company very difficult to contact. We therefore approached Graham Monitoring to provide us with a quote. The quote they submitted covers a new fire panel box, 1 cell line and one landline for a one-time fee of \$1,953.75. Service for 1 year will cost \$400 plus the annual fee of \$156 for our ULC Certificate. ULC is the fire

monitoring standard written by the Underwriters' Laboratories of Canada (ULC). It's the standard that is referenced in Building Codes and Fire Codes. It provides maximum protection and safety. It governs how fire monitoring equipment is installed, how it communicates and how it is maintained. We will be switching to this company in the coming weeks.

Bright and Merry Market

On November 17th St George's opened its doors to the community as we participated in the Bright and Merry Market, a free event featuring live entertainment, tree lighting, and food and craft vendors. Thank you to the many volunteers that worked so hard to make this a success. Finally, thank you to everyone who came out to support and share in this event. Through your support we raised close to \$2,000 for the church. Many visitors came through our church and commented on its beauty, the music and the friendly faces greeting them.

Video Recording and YouTube Channel

The Durham Region in Faith services finished in July 2022 and we began video recording our services at St. Georges in the fall of 2022. The services are available on our YouTube channel available on our website.

Stained Glass Window

Earlier in the summer of 2022 there was a rock thrown through the stained glass window in the south transept. This was repaired by McCaulsland Stained Glass at a cost of \$2,500. Unfortunately our insurance deductible is \$2,500 so we were unable to submit a claim.

Surveillance Monitoring - Security

Corporation has been investigating surveillance and security monitoring for the exterior church. Graham Monitoring to submitted a quote for the installation of video surveillance system including 4 Ring Floodlight Cameras (Black) and a lumen motion sensor light. We would need to ensure we have a Wi-Fi access point for the equipment. The quote is \$7,318.04 (including HST.) We continue to investigate other security and monitoring options

Bequest

We received a bequest of \$199,000 from the Donna Barwell estate (a former Parishioner.) We engaged the services of Kitchen Legal to ensure we adhered to our statutory obligations as members of Corporation for this bequest. This money is currently held in the internally restricted fund and can be used as corporation feels necessary. We are looking at our investment options to allow the money to gain interest.

Donation

A parishioner has donated \$49,478.60 to the church. We are very grateful for this donation.

Staff and Contractors

The Diocese has approved a 3% cost of living increase for incumbents. We offer the same increase to our staff and contractors.

Our staff, William and Cathy, will receive their increase retro to January 1, 2023 Our cleaner, Elizabeth, will receive her increase starting April 1 2023 (this is when her contract is due for renewal)

Carm, our music director (on contract) has requested additional vacation instead of an increase in his rate of pay. This has been granted.

Looking to the Future

We at St. George's have a very exciting year ahead of us. We are embarking on the major undertaking of replacing the church roof, we are looking forward to welcoming a new priest and we are looking for ways to reimagine ourselves in the post covid era.

Our city is growing with Oshawa being identified as the second fastest growing municipality in the province with a large majority of those moving to our city under the age of 40. Over the next 20 to 30 years, 13,500 new residential units are proposed for downtown Oshawa. How might we reach out to our neighbours and minister to their needs? How might we collaborate with those in our community to help those in need? There are many new opportunities God may be giving our church. Let's celebrate and embrace these opportunities together.

<u>Thank You</u>

Thank you to our staff and parishioners for your involvement and support of the mission and ministries here at St. George's. We have much to be grateful for and are truly blessed with continued offerings of thanksgiving as we embark on our next chapter as a congregation. Whatever we are facing into now, no matter how challenging, the light on the horizon is one of hope – that guiding star in the sky, and soon, the beautiful miracle of Easter.

CAST THE NET 161st REGULAR SESSION OF SYNOD, NOVEMBER, 2022

The 161st Session of Synod for the Diocese of Toronto took place during the end of the pandemic and was conducted on-line from November 17 to 19, 2022. As Synod members from St George's, we would like to share selected highlights with the parish. The diocese has prepared a summary in the Anglican newspaper, available on the website <u>www.toronto.anglican.ca</u> click on: news/the Anglican Newspaper/2023 issues/Read the January issue of the Anglican. Synod is essentially the Annual Meeting of the Diocese for both lay and clergy members who constitute the governing body of the Church. Synod began Thursday evening, with a live-streamed Eucharist from All Saints, Kingsway.

The theme of this Synod was "*Cast the Net*" from the gospels of <u>Luke</u> and <u>John</u>. Since January, 2022, the diocese has been embarking on a new process to meet the challenges and opportunities for the next few years.

BISHOP'S CHARGE TO SYNOD

Bishop Andrew told a story from his childhood in Montreal in 1970. He and his brother fished from a pier every Saturday morning. With the other fishermen he felt part of something, a sense of belonging. The family then moved to St Catharines, where the fishing stopped as the river was contaminated. Things were not as they used to be. Likewise, the pandemic changed the Church and we need to discern what the future holds for us. In John 21, the disciples returned to the familiarity of fishing and a fruitless catch. Our instinct too, is to return to what's comfortable. We need to be **honest**. We're tired in the church, the hospitals, our communities. We recognize we have injured First Nations' People in our desire to mission. God is calling us to do things in a new way. What would happen if we were to cast our net on the other side of the boat, on the right side? It is God's command to make connections where He is at work: for housing, for dignity, for hope, for a sense of belonging.

Bishop Andrew concluded with three goals: to renew our commitment to reconcile with First Nations, to become serious about environmental changes as a diocese, and to commit ourselves to antiracism and antibias. God is counting on us to be present in the moment.

WORSHIP – MORNING AND EVENING PRAYERS

On both days of Synod, a variety of prayers was offered by two Religious Orders and the Bishop's Youth Ministry Committee.

PROPERTY COMMITTEE – AFFORDABLE HOUSING

Affordable housing and homelessness are linked. Both structural and systemic factors were discussed along with personal circumstances. The committee is exploring ways to help

parishes re develop their property to include both market level and affordable housing. As well, the diocese is advocating in various areas, like raising the minimum wage, child care, rent control, drop -in centres.

PROPERTY COMMITTEE – ENVIRONMENTAL ISSUES

The committee is exploring how our diocese might become involved with the Net Zero Churches Network which offers expertise and financial incentives to implement solutions.

MISSIONAL AND OUTREACH MOMENTS

These are new ways of meeting people not being reached by traditional forms of church.

- **Parish of Creemore** a Food Bank, with hook up to neighbouring vendors offering fruit, vegetables and plants
- All Saints, Whitby a Community Garden, offering fruit and vegetables, a time of learning and a social gathering
- St John, Bowmanville an outdoor prayer labyrinth, of considerable size on the church grass for their parishioners and the community

EPISCOPAL LEADERSHIP

Since last Synod, the team has been working on a new leadership structure that includes both lay and clergy with support from diocesan staff. There will be three bishops supported by five archdeacons, both lay and clergy, working part time. This new direction offers regional deans, parishes and clergy more support. Bishops will then be able to lead more effectively, and perhaps expand their ministries in new ways.

GOVERNANCE

Synod Council provides strategic direction for the diocese between Synods. The goal of the new governance structure is to facilitate and streamline decision making. This new model is more efficient, easier to navigate, more user friendly, equitable and transparent. This pilot project will be in place until the end of 2023, when Synod will vote on whether the changes should become permanent or the diocese should revert to the former structure.

MEMBERS' TIME

Two periods of time were set aside for members to air concerns about any topic related to the Diocese of Toronto or the Anglican Church of Canada.

FINANCIAL OVERVIEW

Synod was asked to approve a one year deficit budget. Church life is returning to normal and many areas of ministry are starting up again and spending money. The Diocese does not plan additional financial support from parishes.

PRIORITIES AND PLANS 2023 AND FINANCIAL BUDGET

No major decisions will be made until a long term strategic plan is in place. A two year budget will be crafted in 2023. The assessment rate will remain at 24.70%. There was no registration fee for parishes again this year as Synod was held on-line.

CONFIRMATION OF GENERAL SYNOD AND SYNOD COUNCIL MEMBERS

Existing General Synod members will continue to serve at the next General Synod. Likewise, Synod Council will remain in their position for the duration of the governance pilot project.

ELECTION OF HONORARY SECRETARIES

Ms Sheila Robson will be Honorary Lay Secretary; the Rev. Lisa Newland will be Honorary Clerical Secretary; Ms Constance Kendall ODT will become Assistant Honorary Lay Secretary.

WRAP UP

Bishop Andrew thanked the many who contributed to a successful Synod. He thanked Chancellor Clare Burns who is stepping down after twenty years.

Bishop Andrew remarked that we are stepping into uncharted waters together. We will cast new visions and ministries that we feel called to.

On a humorous note, the Bishop hoped we would row with the Argonauts as they play the Winnipeg Blue Bombers in the Grey Cup tomorrow.

Briefing note: St. George's Annual Audited Statements 2022

The audited financial statements included were completed by Debbie Marsh from Smith Chappell Marsh Vilander LLP on February 16, 2023.

The auditor will meet with the Wardens at a Corporation meeting on February 22, 2022. The auditor has given a clean audit opinion. The Wardens will have the opportunity to ask questions about the financials and the audit process to ensure it was transparent and efficient.

This has been a very active year with the sale of Cowan House closing and some significant donations. The church remained open though the fiscal and activities started to ramp up mid-way through the year.

Our parishioners have continued to support the work of the church through their contributions both financial and donated time, allowing the church to end the year with favorable financial results for 2022.

The Statement of Financial Position is strong with assets of \$3,643,888 which includes current assets of \$496,902. This includes \$484,067 in cash (\$251,474 donations currently in internally restricted fund and \$145,544 received out of Cowan House sale to pay for the architect) and \$12,835 in accounts receivable representing HST refund. Liabilities include accounts payable of \$30,897 (mostly invoices from December that came in January) and deferred revenues of \$22,106. The deferred revenue line item is where some committee monies are kept, to ensure they are available the following year for use. Long standing investments continue to pay interest that the parish uses for various activities.

The audited statements include a Consolidated Statement of Operations with an excess of revenues over expenses of 2,249,908. This statement includes the gain on the sale of Cowan House net of expenses. (see below for further details on the sale of Cowan House).

The Statement of Operations by Fund is a view of activity in all funds this fiscal.

- Cemetery Fund Revenues from donations and fund interest. Expenses for cemetery maintenance.
- Internally Restricted Fund Revenues from two donations.
- Rectory Fund Revenue from interest earned in the fund.
- Memorial Fund Revenue from interest earned in the fund and flower donations. Expenses for flower purchases.
- Thomson Trust Revenue from interest earned in the fund and expenses for bursaries.
- Property Redevelopment Fund Revenue from the interest earned on the GIC from August to December 2022 and the gain on the sale of Cowan House.

The Wardens Operating Fund had a budget for the year of (\$24,970) and shows that we ended the year at (92,479) before the fund transfers. A few line items in this statement are worth noting. Revenue from Parish Groups includes, parking rentals, a successful Merry Market sale this year as well as proceeds from the sale of Cowan House items. The Ministry Allocation Grant and expense, represents one month of salary in January 2022. Expenses to note include the fuel that continues to increase every year and the allotment that was \$51,051 this year.

Please find notes that have been included in the audited statements:

Fund Accounting

The Cemetery Fund is administered by the Cemetery Board to maintain the cemetery. A Perpetual Care and Maintenance Trust has been established through the Diocese. The money is derived from the sale of cemetery plots and niches and donations from parishioners and friends. Each year, an amount is transferred from the Operating Fund to the Cemetery Fund to cover the excess of expenses over revenue earned in that fund.

The Rectory Fund exists to provide capital in the event that a rectory must be purchased. The income from the Rectory Fund investments is allocated to the Operating Fund. The book value as presented, reflects the value of the investment as reported on December 31, 2006.

The Memorial Fund is an endowment fund that is used to support the operations of the Operating Fund. It comprises the St. George's Memorial Fund, the Cowan Trust Fund, the Muckler Lady Chapel Trust and the Flower Funds (which include the Altar Flower Fund, Jackson Flower Trust and LeRoy Bequest Fund). Each year, the income from the Memorial Fund investments is allocated to the Operating Fund.

The Thompson Trust Fund provides annual bursaries to members of St. George's Memorial Church to enable such members to attend or continue to attend the university of their choice subject to certain criteria. The selection and award of the bursaries is in at the sole discretion of the Incumbent and the Churchwardens of St. George's Memorial Church.

The Internally Restricted Fund was created by the Corporation to set aside certain bequests and large memorial donations for the purpose of specific projects. These funds are spent at the discretion of the Corporation.

The Property Redevelopment Fund was created by the Corporation to set aside the proceeds of the sale of Cowan House and to account for interest earned on these funds. It is our expectation that all expenses related to the roof project (and hopefully the elevator and office build) will be adequate to cover all our costs. These funds are being held in trust by the Diocese and are restricted for the roof project.

The Operating Fund accounts for most of the Church's program delivery and administrative activities.

Briefing note: St. George's Budget 2023

The budget for 2023 has been approved by the Advisory Board to move to Vestry for final approval.

The budget shows an excess loss of \$12,839 for the year. It includes revenues of \$303,500 plus investment income of \$65,000 and expenses of \$381,339. The last few previous year final numbers were used to create the proposed budget.

2021 and 2022 final revenues were used as comparators. We will continue to "open-up" post COVID with more in-person gatherings and activities. Increased Community Groups and Parish groups as activities increase.

The expenses were based on actual 2022 expenses. The reduced clergy stipend was adjusted to reflect a part-time priest for part of the year and full-time once the new priest is identified. Expenses were increased for church outreach for groups providing meal tickets and additional activity starting up again.

The budget does not include proceeds from the sale of Cowan House which will be tracked and reported on separately with a separate budget for accounting.

ARCHIVES REPORT TO THE FEBRUARY 2023 VESTRY MEETING

Most of the archival files have now been stored in acid-free document cases and many of the files have been changed over to acid-free file folders. This will help to preserve the archival collection of the history of St. George's Memorial Church. This change over is an on-going process.

The minutes of the Advisory Board/Parish Council meetings have been located for most of the years back to 1960 and are now in the archives. The minutes for the meetings prior to 1960 are stored in the diocesan archives. I have done a summary of the main topics of interest that were discussed at these meetings. This summary will greatly assist in the retrieval of information.

The staff at the Oshawa Community Museum have photographed our 1881-1925 Minute Book which had deteriorated over time and we have a digital copy in the archives. The original book has been sent to the diocesan archives where it will be stored in a temperature and humidity controlled environment. A conservator will work on repairing the damaged pages.

I came across six silver medals in the archives that had been presented to boy choristers. These medals were referred to as the "Cowan Medals" as they were given by Mr. Cowan at Christmas time to the boy choristers who were leaving the choir mostly because of the change in their voices. Three of these medals were from choristers from the previous St. George's Church choir (pre-1924) and the medals contain a view of the previous church. The other three are post 1924 and contain a view of the present church. I thought that these medals deserved a special place in the archives and enlisted the creativity of Bill Fitches to help develop a suitable presentation. We now have the medals beautifully framed and two explanatory pieces that I prepared to go alongside the medals.

Bill Fitches has also reframed one set of the cutlery that was probably bought in the 1920's. The cutlery is stamped with "St George's Church".

The oversized scrap books that contain much of St. George's history were in need of some attention as some of the items had started to fall out. Win Desmond kindly volunteer to go through these books and reattach the items that have become, over time, detached from the pages. This work is continuing.

2022 CHANCEL GUILD VESTRY REPORT – December 31,2022

The first two months of 2022 was a continuation of the previous year.....services were shut down after the 2021 Christmas Eve services. Filming of services, however, was continued by Pastors Judy and Ian Martin (of St Matthews). Judy and the Wardens made the decision to reopen effective February 13th, 2022.

As of January 1, 2022, St. George's Chancel Guild consisted of five women working on a three-week rotation: Norma Chapman-Holder and Barb Wotton, Margaret Lapierre, Pat Heffering and Marilyn Glover. Bill Fitches is not a regular member of the Guild but continues as the Flower Convenor, and for that we are thankful.

During 'normal' times, Chancel Guild duties include preparations for the Holy Eucharist for Sunday and Thursday services, as well as weddings, funerals and baptism. We are responsible for changing frontals as required, and keeping the linen clean and fresh. Making sure there is enough clean linen for the Easter and Christmas services can be a daunting task.

Our group tries to have two meetings during the year, these being prior to the major celebrations, where we discuss preparations for the Easter and Christmas services. At the meeting before Easter, we drape the Crosses......Altar, Lady Chapel, Verger's and Crucifix.....in appropriate veils, as well as prepare palms to decorate the Processional Cross, and the Children's Cross. We ensure the palms are in place for distribution on Palm Sunday. In the past we have celebrated our Corporate Communion at the Palm Sunday service......but the meetings nor the Corporate Communion happened this year.

We were saddened to hear of the passing of Jean Crook on May 29, 2022. She was a long time member of the Chancel Guild, even working up until she turned 90.....she ended her involvement at the end of December 2016......Purificators, to be blessed in her memory, have been ordered.

In 2022, we have set up for three weddings and three baptisms. We have also set up for Funerals/Memorial services for Betty Raitt, Jeannette Smith, Nancy Miller and June Wildman.

At the end of July, we said 'happy retirement' to Pastor Judy and September 1st we welcomed Interim Incumbent in Charge Richard Newland.

We have an incredible team, and I thank them for doing this work tirelessly, with love and care. We have had a notice in The Standard since October 6th of this year, asking for parishioners to step forward and join us; as of the end of the year, no responses have been received.....maybe 2023 will be year we can bring new members into the group. I would be happy to spend time with anyone interested in this ministry.

Chancel Guild is a "behind the scenes ministry", and has been described as "light housekeeping for our Lord". PROJECT COMMITTEE REPORT TO VESTRY 2023

Background:

Members of Parish presented a proposal to the Diocese Risk and Governance Committee in June 2023. At that time the Diocese did not approve our request and required us to obtain Architectural drawings and specifications as well as a project manager before they will approve our project. The Diocese required us to get 3 quotes from different architects. At that time we felt it important to establish an ad-hoc committee to oversee the project. We also decided that, as we were required to enlist an architect, it would be prudent to have them include the architectural work for the elevator and upper hall offices as well. Serving on the committee are Frank McGilvery, Terry Dragomatz, Steve Rowe, Shannon Bott, Margaret Lapierre, Bill Reitsma and Barb Wotton.

Terms of Reference

The Project Committee first met in September 2022 where the work to date was reviewed and the terms of reference for the committee were created:

- Committee will determine who the Chair will be
- Committee to create a budget for the project and monitor
- Create a timeline for all of the steps for the committee and the work
- Committee to select architecture firm
 - o Review quotes
 - \circ establish a matrix for selection
 - \circ $\;$ establish interview questions for interviews
 - o Committee to select architecture organization
- Committee to create and review updated proposal to Diocese
- Committee to monitor construction process

Architect Quotes

The committee obtained 3 quotes from the following architects:

- Charles Sopher (approx. \$100,000 project manager not included)
- David Bovill, from Barry Bryan Associates (\$128,800)
- Kelly Gilbride from Stevens Burgess Architect along with Ted Katsoris from Morrison Hershfield Limited. Kelly Gilbride and Ted Katsoris have submitted a joint proposal. (\$235,730)

Interviews were conducted with each of the architects on zoom using a standard set of questions. Following the interviews the committee met on November 2nd to discuss the interviews and score them based on a scoring matrix.

Based on the interview questions and scoring matrix, our decision was to engage Barry Bryan and Associates. Their quote was the most inclusive and the team felt that as they are a local company they will be familiar with our community and municipal requirements. We secured references for BBA, all of which were very favorable.

Initial Investigative Work: Water Ingress Mitigation

The committee met with David Bovill (Principal & Engineering Manager) and Chris Earle (Senior Technologist) of Barry Bryan Associates (BBA) on December 2nd and decided that the first step was to mitigate the water ingress on the flat roof section between the church and the parish hall as quickly as possible with a preference to do the complete roof work on the flat roof section if this is can be achieved. If the complete roof work to this section of the roof is not possible at this time, then temporary measures will be put in place to reduce water ingress. Foran's Roofing in Whitby has been approached by BBA to do the initial investigation of the leaking flat roof section. They will use a boom truck to access the roof (one day), do test cuts to determine the existing roof assembly and assess its condition. Test cuts will be patched the same day. Formal approval for this work was given by the committee on January 10th Due to the wind event over the holidays they are very busty patching and repairing roofs and would be available no sooner than the beginning of February.
